# Windrush Creek Property Owners Association Meeting August 27, 2019

### By-Laws Committee:

Carole Bickel, Vivian Witkind Davis and John Alton were in attendance from the committee. They initiated the discussion to review and answer any questions regarding:

# SUMMARY OF PROPOSED AMENDMENTS TO THE WINDRUSH CREEK SUBDIVISION AMENDED AND RESTATED DECLARATION OF COVENANTS, RESTRICTIONS, EASMENTS AND ASSESMENTS

- Summary was given to each Association member on May 15, 2019
- This time frame provided a minimum of forty-five (45) day notice to each member
- Nineteen (19) votes equaling at least three-fourths (3/4) of the total number of votes cast at the meeting were necessary to adopt this Amendment. 15 Families were present and four proxies were submitted making a total of 19 votes.
- The number of votes cast by the Association members at the meeting totaled Nineteen (19) which amount exceeded/equaled the twelve (12) votes required to constitute a quorum.
- Zero (0) votes were cast at the meeting against this Amendment.

# Election of Officers:

Trustee: Chris Imwall was unanimously voted in approval as a permanent Trustee for a two-year term. Congratulations Chris!!!!

Laura Davis, who is filling in as treasurer, reported that all dues have been turned in and paid by each association household.

#### Landscape Committee:

Report was given that the committee has met with Franklin Soil and Water.

- There is a 10- foot area by the pond that is not being mowed and rain garden type plants are in this area to attract wildlife, keep the area healthy and pleasant looking.
- A tree has been purchased and planted in honor of Doug Dachenbach. A dedication ceremony is planned for September 21, 2019 at 10:00AM.
- Mild renovations have been made to main entrance of each section. Section 1 has received stone/gravel improvement and both sections have mums planted.

# Pond Committee:

Jan Elzey was not present but gave update to Phil Davis to share.

- Aqua Docs is still maintaining the pond. A check on the service aeration was performed.
  Cost was \$218.00.
- Aqua Docs contract also included removing, storing and cleaning the fountain.
- All portions of the pond will need to be deepened. Estimated cost will range from \$17,000 to \$32,000. The Pond Committee and the Capital Improvements Committee are working on receiving bids and further discussions will be required.

# Social Committee:

Phil Davis shared that we do not have a chair for this committee. Because of this, the Halloween party is on hold and we do not have a date or time scheduled. If interested, please contact any one of our trustees.

# Other Concerns/Discussions:

Concerns were raised regarding the idea of selling off common area property. This was a discussion that occurred at the previous property owner association meeting as a way to finance capital improvement projects that were being discussed (old tennis court area). Phil Davis reported that there have been no further discussions among the trustees at this time.
