



Just keeping common areas grass green, cut on a regular basis.

Allow common property grass area between Windrush Lane entrance and pond to return to prairie and eventually woods. Other common areas could be considered for this too (aka along walking path). This would cost nothing up front, be sustainable (fertilizer and mowing no longer required), would enhance community privacy from Taylor Station's crazy amount of traffic, and save the POA many thousands over the years. This would make our community more private and be a long term positive for home values. There would still be open grass for the rare play and other open space use by the pond and at the circles. Good for wildlife and the planet-- as woods are a carbon sink. The grass is just grass, and while better than concrete, is really not used by the community.

More native plants, drought resistant plants. (Milkweed to attract butterflies.) 





We could do all of the management tasks if we consistently had dedicated and accountable volunteers from the community. However this is not the case. If we want to be serious about "Green Windrush", let's abandon the idea that our common spaces should be quasi-golf course like, and let most of them go natural. (most, but not all). We have the perfect example across the street at the park. We'd rather feel that we live somewhere that has common areas headed toward being "woods" vs being boring blank lawn addicted to chemicals. This would be a plus long term for community property values, and our values in general.

I neglected to mention an important fact pertaining to the use of the fire pits. Our house happens to sit higher than most in the neighborhood. Since the winds generally blow west to east and sometimes out of the south during the warmer months, we are in direct line for smoky air. There have been many times when the fire pits are in sues, that we have not been able to be outside in the yard. I have a heart condition and [my spouse] is 75 years old. For us, breathing smoky air is a true health hazard. Please take these facts into consideration when considering fire pit outcomes. Fire pits didn't even exist for the first 25-30 years we lived in this neighborhood. At the very least, thee should be a rule that fire pits can only be used after dusk.

If you are living in this housing price point you should be able and expecting to pay to maintain the property by hiring skilled companies/vendors to complete and maintain the property.

I think several dog poop bag dispensing and collecting stations in the green spaces would be a great idea as many people don't pick up after their dogs, particularly when it snows. This is pretty annoying considering how many times we've stepped in it, and the potential for spreading disease... not to mention: ew.

My family's biggest challenge/issue with being a part of the Windrush POA is that the neighborhood amenities are not easily accessible from our property. In fact, when we first moved in, there was zero access. We have since cut a little path through the woods - but it's extremely soggy for most of the year, and extremely dark at night, which hinders our family from taking full advantage of the neighborhood (which we have no choice but to pay the dues). And yet, we pay the same amount each year as our neighbors who have direct access. I have brought this up many times over the years, and have had many a conversation with some of our past POA Presidents. And each time, they've stopped by and agreed that we do indeed have poor access, but never offered to help us with a solution. We've asked to pave the path and add a small light, and have our annual dues waved until the minimal cost was covered, but each time we were denied. We simply gave up. So I guess I ask you...would you spend time offering your thoughts on how to beautify the neighborhood, volunteer to hold a position within the Association, or spearhead an event, if you felt like the neighborhood Association was aware of the lopsidedness of your property inclusion, but turned a blind eye? We feel that, to the POA, we are not neighbors, we are simply the family that pays \$430/year because "they have to". It might be easier to just remove us from the database.

I think we should have a sort of "Mission Statement" for our community that gives a general impression of what our goals for our neighborhood are. For me, during this time of lock down and isolation, I have seen neighbors taking advantage of the natural beauty of

our community more and more. More folks are walking the paths and streets, waving and distance chatting with one another. Driving around in the JT (Jefferson Township) I see more and more tightly packed housing with straight streets and postage stamp yards going up and beautiful old trees coming down. There will soon be a community of dwellings for empty nesters down at the end of Taylor Station Rd. I think we should remain committed to being a place where it is safe to get out and breathe fresh air and enjoy the natural world, and as part of that we should commit to naturalizing our areas with less formal "gardens" and more eco-friendly plantings. As I said earlier, this lock down time has emphasized the value of being able to be nurtured by nature just outside my own yard. When the path and the fire pits first went in it was great to see how neighbors began to get together and get to each other better. This is one reason I think a permanent shelter by the playground area could benefit many of us.

How could we encourage more community involvement and neighborly interests among residents?

Besides the playground area, the neighborhood is really great. Once the playground-no playground debacle can be put behind us I believe many residents will be more satisfied.

Fences! I know people want this "open" look, but it's a safety issue with dogs. Yes, there are electric fences that people can have their dogs trained to be on (if it works for their dog - I use to have a dog that would not respect it). More and more children are moving into the neighborhood and I think it is selfish for people to put children and other pets at risk of a dog bite or worse for their "pleasing aesthetic". My next door neighbor has their dogs on e-fence and it has failed numerous times. I've had to bring my children in from playing to keep them safe.
